At the Annual Business Meeting of the Assembly, the changes in the Constitution and By-Laws previously circularized to the membership were unanimously approved. The revisions approved change the dues structure as it pertains to Institutional Members to separate WHA dues from those of the AHA. The WHA dues for Institutional Members are not changed, but merely separated from those of AHA, thus permitting WHA to fix its own dues so that they are not tied to those of the AHA. Dues of Type A Personal Members were increased from \$2 to \$5 per year and for Type B and C Personal Members from \$5 to \$10 per year in the revisions adopted. Other revisions approved did not basically change the By-Laws but merely clarified them, eliminating inconsistencies, and making necessary typographical changes. As soon as these changes have been made and new copies of the By-Laws printed, they will be sent to the membership.

The complete minutes of the business transacted at the Annual Meeting of the Association will be sent to all members within the next several weeks.

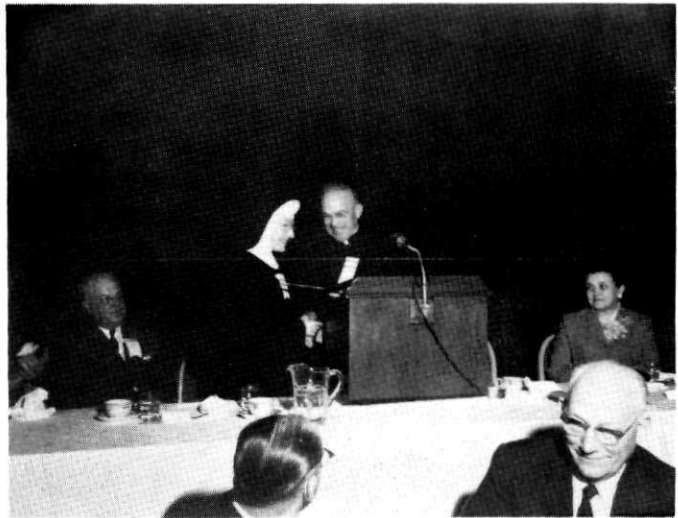

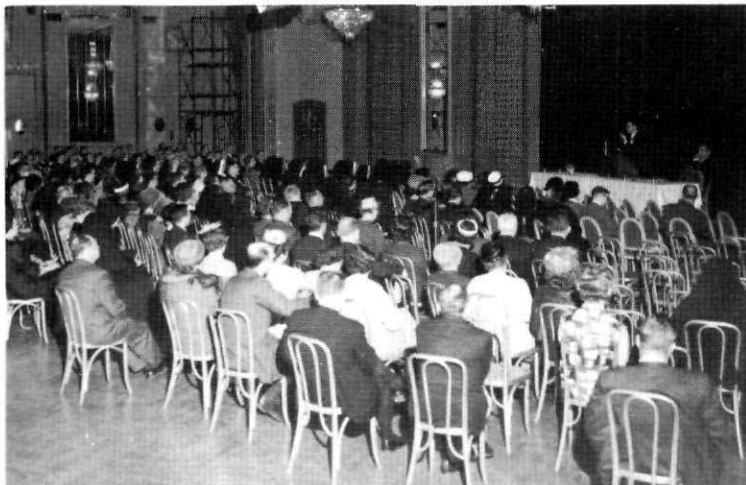

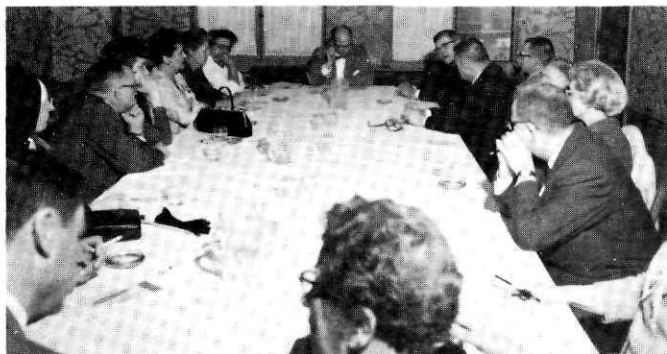

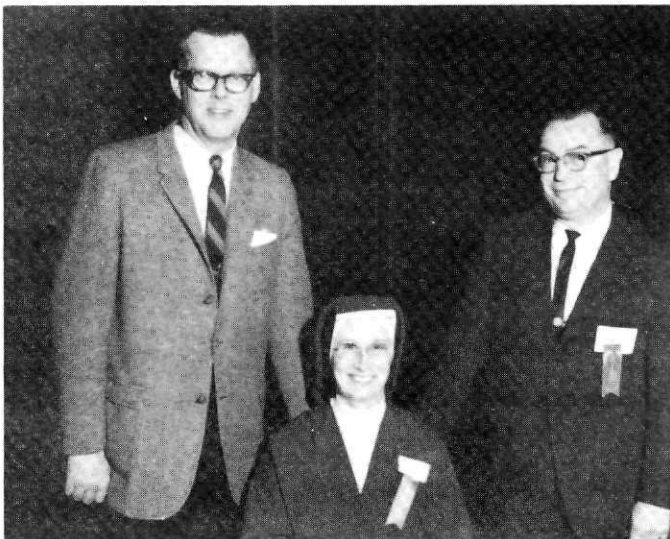
