Application Process

To Apply:

- Complete the required applicant information form by clicking on the link provided. We encourage you to complete the application form in one sitting. Please fill out each section with as much information as you can. If you don't have specific information for a particular field, simply enter "N/A."
- Applications must demonstrate clarity, adherence to required categories, and evidence of best practices. Please reach out to us with any questions you have during the application process.

Submission Guidelines

- Multiple applications per organization are welcomed.
- Each application must reflect an improvement project completed within the last 12 months.
- Incomplete applications will not be considered.
- Applicants will receive email confirmation of application receipt.

Review Criteria

The WHA Quality team will conduct an initial review of all submissions for completeness. Completed applications will then be evaluated by the team based on the following five categories:

- 1. Process of identifying need and project scope
- 2. Leadership and planning
- 3. Process improvement methods
- 4. Results
- 5. Lessons learned/sustainability
